Extended Care

Our extended care service is available for K-8 students after regular school hours. Service is charged in 1 hour increments and begins once students are signed in, and ends when they are signed out. **Monthly Prepaid Flat rate options are also available.** Plan changes may be processed once each year. Additional plan changes will incur a \$50 plan change fee. All drop-in extended care charges will be billed through FACTS at the end of each month due within 14 days. Acknowledgments

Parent/Guardians understand that the breach of any of these agreements and/or rules as stated in the *Parent/Student Handbook* by any student or parent is subject to disciplinary action. Any violation deemed serious may result in the expulsion of the child from Blessed Sacrament School.

CONFIDENTIALITY

Parents/Guardians understand that I will only discuss financial issues of concern, with the Business Manager of the School, rather than other parents. These matters are confidential and should NOT be discussed with others unless there is written consent by Blessed Sacrament School or the Roman Catholic Diocese of Orange.

TUITION PAYMENT

Parents/Guardians understand that prompt payment of tuition and fees ensures the necessary cash flow for the operational expenses of the school and that it is a condition for children to remain in the school.

Parents/Guardians understand the enrollment fee is payable at the time of enrollment, and that tuition is due as determined by my choice through FACTS tuition management and is considered late if not paid on the date choice as determined by me through FACTS tuition program.

Parents/Guardians understand that a late fee of \$50 is charged if this deadline is not met.

EXTENDED CARE

Parents/Guardians understand to ensure that my child/ children arrive at school or scheduled activities on time and will be picked up from school /activities at the scheduled time or before the closing of Daycare at 6:00 PM.

DELINQUENT TUITION PAYMENT

Parents/Guardians understand that if Parent/Guardians neglect to pay our tuition on time, or do not make our monthly tuition payments, a temporary or permanent dismissal of my/our child/ren may result.

Parents/Guardians understand the financial assistance process must be utilized and initiated by the parent(s), and that with established procedures and parent communication, there is no reason for an account to become delinquent.

Parents/Guardians understand that if I fail to make the required tuition payments, I will not be able to enroll my child/children at Blessed Sacrament School or any other school in the Diocese of Orange(Elementary or High School) until Blessed Sacrament School is paid in full.

COLLECTION OF OUTSTANDING TUITION AND OTHER FEES

Parents/Guardians understand that if I/we incur an outstanding balance, may prevent me from being offered re-enrollment for the following academic year.

NSF (Non-Sufficient Funds)/RETURNED CHECKS

Parents/Guardians understand that at any time during the school year, checks that are returned from the bank unpaid may accrue an additional charge of \$35.00 per returned check and that replacement payment must be made by cash or money order. If the check is for tuition a late fee will be collected through the FACTS tuition program.

Parents/Guardians understand that this includes any and all monetary transactions for daycare, sports, field trips, etc.

SERVICE REQUIREMENTS

Parents/Guardians acknowledge that I/we have received, read, understand, and agree to abide by the **Service Requirements** and obligations.

Parents/Guardians understand that if my/our child has entered the school after the school year has begun, I/we am/are expected to participate/buy out the remaining **Service Requirements** on a prorated basis.

Parents/Guardians understand that if my/our child leaves the school before the school year is ended, I/we am/are expected to participate/buy out the current service requirements on a prorated basis.

TUITION ASSISTANCE

Parents/Guardians understand that if I am awarded tuition assistance, **(not applicable if no assistance is awarded)** I am also bound by the stipulations stated in the offer letter.
